Give your grinder pump air!


Let it breathe! Let it breathe!

If you are going to landscape around your grinder pump,
the grade around the pump should be
a minimum of 4" below the top of the lid
and sloped away from the unit.

Never cover or obstruct the air vent openings in your grinder pump.

In a failure situation back flow water would empty into your house rather than on to the ground if the vents are blocked. Gross! \$\$\$\$\$

WRWSD Board of Trustees Meeting – Sat., September 10, 2016

Secretary Prescilla Redick called the meeting to order at 9:30 a.m.

Roll Call: Present: Beresford, Buskey, Purdin, Redick & Mgr. Cahall

Absent: Beard (ex.), Bridges (ex.), and LaPlante (ex.)

Minutes: A motion was made by Purdin and seconded by Buskey to approve the minutes of the August 29th workshop meeting as read. A yea/nay vote was taken and the motion passed unanimously.

President's Report: none

Treasurer's Report (John Buskey):

- At two-thirds of the way through 2016, income for the WRWSD continues to "track as expected". For the most part expenses are also, except for electricity, telephone, water testing costs and credit card charges. When asked if the increases were 'inflationary or possibly caused by something else' Buskey shared that he was looking into the electricity and phone increases. The water testing increase is due to additional testing requirements by the Ohio EPA and the credit card charge increase is due to the amount of usage. Buskey noted that it will be necessary to amend the 2016 budget by motion in the near future (as required by the State of Ohio) to reflect these discrepancies.
- In early September a total of \$67,143.00 in delinquent accounts was certified to the Brown County Auditor for collection. The details of this transaction will be shared with the Board at the next meeting.

Manager's Report (Paul Cahall):

- The WPOA maintenance staff will work with the WRWSD staff to do the asphalt repair work needed on a driveway following the repair of the water leak on Atoka Dr.
- The gate at the water/sewer plants has been repaired and is working well.

• The WRWSD maintenance staff and the WPOA staff have been working together this past week to unclog the wastepipe at the Campground's dump station as well as to repair the water line damage that occurred during the process.

Board Member Concerns: Purdin requested prayer for Doris and Tom Kitchen as Tom is 'gravely ill'.

Membership Concerns:

<u>Roger Coker</u> (Lot 1888): Coker asked how a property owner could gain access to the WRWSD plants. Cahall told him that the property owner would either be given a code to use at the gate or be escorted into the plants.
