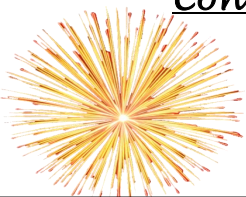

Treasurer Report Month Ending February 2020

Operating Funds

February total operating income was \$215,000.00.

February total operating expenses were \$170,000.00 with no unexpected expenses.

Operating fund balance at the end of February was \$379,014.14

Operating income for the year at the end of February was \$387,000.00. That is 18% of the plan for 2020. Expected income at the end of February was 16% so we are 2% over budget.

Operating expense for the year at the end of February was \$328,000.00. That is 15% of the plan for 2020. Expected expense at the end of February was 14% so we are 1% over budget.

Allocated Assessment Funds

Income for allocated operating assessments in February were \$158,000.00

Assessment account expenditures in February totaled \$48,000.00. This was mostly the resurfacing of the indoor pool and hot tub and a new truck for maintenance.

Balance of all allocated assessment accounts at the end of February were \$305,811.61

Invested Funds

Invested Reserves at the end of February totaled \$479,767.56

Total cash on hand at the end of February was \$1,164,593.31

Rules and Regulations Committee

From: John Buskey & Vernon Taylor, Co-Chairs

The Committee met in March and worked on amendments to the Rules and Regulations. Motions to amend the General Rules and Regulations, the Election Procedures Manual, and the Building/Zoning Requirements were presented to the Board and discussed at its workshop on Monday, March 9, and will be voted on at the March 14th meeting.

The Revised Restrictive Covenants have been sent to Attorney John Jolley for legal review. And we are waiting for a response.

Managers' Report

- The valve on the main lake is closed and will reopen for 7 to 10 days sometime in April for one more draining of the lagoon. This should result in a temporary drop in lake level of less than a foot.
- The WPOA will be offering four styles of sweatshirts and one t-shirt for the 50th anniversary for sale. Order forms are available at the Office, Lounge and Recreation Center
- Reminder that the Administration Office is now operating under summer hours. The office is be open Monday through Friday 8 am to 4 pm, and Saturday 8 am to noon.
- Maintenance made some repairs on the spillway while the lake was down and to this point appear to have be very successful. We will continue to monitor this area.

Little Turtle Docks – 400 ft of dock has been replaced. Maintenance is wrapping up the last of the upgrades in this area of shoreline protection, graveled pathways and new stairs. This should greatly increase the ease of access to the area.

Quachita Docks - On the east side of Quachita we have installed over 200 feet of new dock and rocked the shoreline along with new access points. On the west side we have installed 10 new rental docks. We continue to work on some new parking areas.

Hiawatha Docks – We replaced 5 post and some cross members and top boards to extend the useful life of this dock area. This area is currently scheduled for replacement in 2022.

- We are working out the final details for a new Restaurant operator this year. The plan has the restaurant open as a set down as well as takeout operation. It is also planned to be open on the weekends during the winter.
- We purchased a new truck for maintenance. This brings the count of vehicles in maintenance not built this century down to 3. The current plan gets that count down to 0 in 2024.
- Campground will have a soft opening on the 28th of March. The water and electricity will be on and the bathrooms will be open for use. Official opening is the 1st of April. Maintenance is hard at work getting it ready for the year.
- Maintenance is hard at work getting all the equipment ready for the season.

Golf Cart (Renewal)- Current membership card, and answer questions pertaining to the renewal.

UTV- Current membership card, current state registration and inspection form must be completed by a Police Officer.

-Our committee has reviewed the Boating and Fishing Guide and General Rules and Regs (Vol 1) yellow book, and after discussions with the Board Trustees, we had determined the B&FG will remain unchanged for the 2020 boating season.

-Remember, there is an upcoming Ohio Boaters Safety Course offered on 28 March 2020, in the Lake Waynoka Lodge. Check it out – don't miss this opportunity to get your safe boater certificate. The Lake Waynoka maintenance personnel, led by Marty, have completed the dock repairs our committee submitted in February. Long Range Planning Committee March 2020 Report

1. The committee discussed the progress to prepare the 2020 - 5-year plan. Activities included meeting with the General Manager to evaluate those maintenance activities, which could be delayed or advanced, those costs which need to be increased or reduced. The result of the review continues to cause each of the next four years expenditures to be less than the projected income. The final report will be issued to the WPOA board at the end of March 2020.
2. The committee is looking forward to a joint meeting with the WPOA board to discuss the duties and responsibilities of the LRPC.
3. The committee has prepared demographics related to the trends of home building, trends of election results and the distribution of the Lake Waynoka age groups in the community. Additionally each of the three Capital Assessment accounts have been documented by the scopes of work proposed for each the next 4 years. Additional projected revenue, carryover costs saving from the past year and the expenditures by year are included. The purpose of the documents is to ensure the board and membership that we are not spending more than the income we generate.
4. We reviewed the committee goals that were set in 2019 and we completed 5 of 6 goals. The goal, Survey Monkey was related to the collection of information to understand the membership opinions to be shared with the WPOA board. This process is a survey process administered by the LRPC. This process is the least expensive manner of sending opinion questions to the membership wishing to participate through Internet emails. Those anonymous opinions to topics are collected and compiled for the WPOA board. The WPOA board should take into consideration those opinions when developing policies and decisions related to the WPOA.

Treasurer Buskey and Mgr. Cahall will have a meeting to discuss finances of each project.
