## **Treasurer Report Month Ending October 2020**

### **Operating Funds**

October total operating income was \$105,000.00.

October total operating expenses were \$170,000.00 with no unexpected expenses.

Operating fund balance at the end of October was \$860,862.86

Operating income for the year at the end of October was \$1,956,000.00. That is 90% of the plan for 2020. Expected income at the end of October was 92% so we are 2% under budget.

Operating expense for the year at the end of October was \$1,689,000.00. That is 79% of the plan for 2020. Expected expense at the end of October was 85% so we are 6% under budget.

### **Allocated Assessment Funds**

Income for allocated operating assessments in October were \$12,000.00

Assessment account expenditures in October totaled \$16,000.00.

Balance of all allocated assessment accounts at the end of October were \$511,640.29

### **Invested Funds**

Invested Reserves at the end of October totaled \$483,553.72

Total cash on hand at the end of October was \$1,856,056.87

## **Managers' Report - Paul Cahall**

Reminder to all boat owners with boats still in the water, we will be opening the valve to drain the lagoon for WRWSD in late November. We are hoping to take the lake down about 5 to 7 feet depending on the weather.

The finance committee has submitted the recommended budget for 2021. The board will now be reviewing and making changes for a possible approval at the December meeting.

Long Range Planning Committee is working on the capital budget for 2021 along with updating the 30-year plan. Their recommendations will be presented to the board in December for their review. We expect to pass the capital budget in January.

We have worked out a contract with Aqua Doc for next season for treatment and control of weeds and algae. We are requesting from ODNR permission to put another 100 grass eating carp in the lake for next year.

The Eastern Fire District now has certified commercial building fire safety inspectors. They will be conducting courtesy fire safety inspections of all our facilities over the next couple of months. They will be providing us list of recommended upgrades.

In 2021 we plan to continue to do more preventive maintenance and inspections of the spillway of the dam. We will be working with Buckeye engineering and CT consultants to ensure the spillway will be in good working order for the next 50 years.

We will be wrapping up dredging for the year by Thanksgiving. We have been very successful this fall in removing thousands of cubic yards of silt from Atoka Cove area.

Because of the uptick in COVID-19 and constantly changing rules please watch the website and Facebook for updates concerning WPOA sponsored and club sponsored events. If these events change, or are cancelled this is where we will make those announcements. We are in constant contact with the Brown County Health Department for updates on what we can and cannot do.

**Other News from Police/Security**

During the Month of October, 10 traffic citations were issued, five of those were issued for driving under suspension. 4 misdemeanor citation were issued for the following violations, trespassing, drug possession, drug abuse instruments and criminal damaging. Other calls consisted of suspicious person (s)/vehicle (s), 911 hang ups and a vehicle fire that is under investigation by the Ohio Fire Marshall Office.

A new real estate entry form was created and introduced in the later part of September, which allows visitors to enter the community and view real estate while obtaining more information for this office to view and track for possible abuses. The forms are working well, and we now can track how many were issued per month. October had 22 forms completed and submitted.

The Lake Waynoka Police Department provided support for the Campground Trick or Treat and the Security Office did a great job with documenting entry passes and moving the traffic into the community.

**Marine Patrol**

16 hours of marine patrol was conducted during the Month of October. No issues or warnings were noted. The patrol boat is scheduled to be removed during the first weeks of November.

If you **LIKE** the dock you have this year and would like to have it again next year;

Between ***April 1st,2020 and December 15th,2020*** either call or come into the Administration Office and pay the **\$50.00 NON-REFUNDABLE** reservation fee.

Between ***January 1st,2021 and March 15th,2021*** you **MUST** pay the annual rental fee of **\$250.00**. You can not pay for your dock a full year in advance!



If you do not like your dock this year, you can come to the Administration Office on ***April 1st,2021*** to pick a dock from those available on a first come basis.

## Dredging Options Report to WPOA Board of Trustees.

**President's Message:** On November 9, 2020 the WPOA held its workshop. The board heard a report about Dredging Options for the lake from a civil engineer and an industrial engineer. This full report is included in this newsletter and will be published on the internet. There will be an opportunity to discuss the report with the authors at an upcoming WPOA meeting. The report examines four dredging options, the advantages and disadvantages of each, and the approximate cost per member per year. The report had several objectives:

- ♦ *Each of these options should meet the Lake Committee and WPOA board objectives for the community*
- ♦ *Each of the options must be within the Rules of HB 5312, the goals that the Board set for itself by adopting the 8 goals.*
- ♦ *Create the least disturbance for the lake community*
- ♦ *Create a goal that can be maintained for the next 30 years to keep Lake Waynoka in a healthy condition for boating, fishing, skiing, and many other activities associated with the lake.*

## Lake Waynoka Dredging Research

November 2020

### Dredging Options:

#### • Define the Issue

- The purpose of this research presentation is to inform the WPOA Board, of barriers that may lie ahead in choosing an option related to the dredging issue.
- Develop options that address the East Enders Questions
- The East End Group asked questions at the October WPOA meeting
- There are several options that can be considered.
  - Option 1 Continue the existing dredging program
  - Option 2 Embrace the Hydraulic dredging program
  - Option 3 Embrace the Bulk dredging program
- Each of these options have advantages and disadvantages
- Objectives
  - Each of these options should meet the Lake Committee and WPOA Board objectives for the community.
  - Each of the options must fit within the Rules of HR 5312, the Goals that the Board set for itself by adopting the 8 Goals.
  - Create the least disturbance to the Lake community
  - Create a goal that can be maintained for the next 30 years to keep Lake Waynoka in a healthy condition for Boating, Fishing, Skiing, and many other activities associated with the lake.

# Dredging Option 1

- **Current Dredging Operations 2020**

- **Description**
  - The current dredging operation consists of the use of pusher barges, excavator barges, excavators, and dump trucks to remove silt from coves in the lake. The strategy for this operation was developed from a similar program used at Lake Lockengrin in Ohio. The program is deployed at the Lake Waynoka for about a six-month period of the year (April to September). The equipment is operated by the existing maintenance force. The excavated material is deposited into the barges by an operator, pushed to an unloading station, where a land-based excavator scoops the material from the barge and the operator then drives the loaded dump truck to a disposal site to be spread. The operation started about 5-6 years ago when the lake procured manufactured barges, excavators and dump trucks.
- **Objectives**
  - Achieve a depth of the lake that is acceptable for Pontoon Boats
  - No damage to existing dock and structures
- **Advantages & Disadvantages**
  - Better quality of lake
  - Capital to be spent
  - No increase in member assessments.

# Dredging Option 1A

- **Potential Dredging Operations 2020**

- **Description**
  - Achieve a depth of the lake that is acceptable for Pontoon Boats
  - No damage to existing dock and structures
- **Objectives**
  - The recommendation is to study this option more.
  - The main factor is the volume of silt we have and how fast we want it gone.
  - What is the volume of silt for normal maintenance must be considered.
  - With this option we may have enough capacity to eliminate some of the 8-year dredging at the East End.
  - A more detailed study will be required to determine what is practical as it relates to silt volume, capital dollars, storage capacity and labor.
  - It is possible we may be looking at a long-term cost savings.
- **Advantages & Disadvantages**
  - Better quality of lake
  - Capital to be spent
  - Increased member assessment



## Dredging Option 2

- **Hydraulic Dredging Option**

- **Description**

- This operation has already been accomplished. The operation involves the mobilization of hydraulic pumps, boats, hoses and fabric collection bladders. Access for lake equipment is on property owned by the lake, disposal of the sediment is deposited on the east end of the lake and removed by lake maintenance work force after a drying operation is completed for 6-9 months.

- **Objectives**

- Achieve a depth of the lake that is acceptable for Pontoon Boats
    - No damage to existing dock and structures
    - Obtain bids for this objective based on the location, channel for boats

- **Advantages & Disadvantages**

- **Disadvantages** – the limitation of the dredging is a function of the number of pumps and the distance between the floating inlet structure of the hydraulic hose and outlet at the east end disposal area, the added cost for this operation is not in the 5-year plan and must be budgeted per the covenants and the Ohio HR5312 rules. The disposal area for fabric collection bags is limited by the current area for disposal of silt material.
    - **Advantages** – The lake level does not need to be lowered, lake activities are not impacted, this operation has already been included every 8 years, but for a limited amount of quantity to be removed (7-9,000 cubic yards (CY)). The equipment will not threaten or damage to existing homeowner docks, the road mud will be minimal, The scope of this work did cost \$190,000 and was completed in 4 months. Additional funds would be required if this option would be used west of the location previously completed. The 5-year plan funds the removal of the same amount of quantity every 8 years. Should the quantity be come larger, the cost will increase, and a smaller amount of assessment will be added, that amount of funds will be dependent on the size of the quantity of sediment to be removed.

## Dredging Option 3

- **Bulk Dredging Option**

- **Description**

- This option involves excavating the lake to its original shape without damaging the lake bottom. This operation involves lowering the lake level sufficiently to allow heavy equipment to access the lake, excavate sediment into dump trucks, driving the trucks onto Lake Waynoka Drive and driving the trucks to a disposal area where existing sediment is stored at the North side of the lake under the transmission line.

- **Objectives**

- Achieve a depth of the lake that is acceptable for Pontoon Boats
    - No damage to existing dock and structures

- **Advantages & Disadvantages**

- **Disadvantages** - Access to the shallow end of the lake is limited due to large turning radius of large equipment, the Lake must be dried out to allow large equipment to maneuver in the bottom and access points, the lake must be lowered 7-8 feet to allow stream runoff to be captured and the only exit point for the runoff is a single valve structure near the dam, the muddy trucks will exit the lake dripping mud thus causing a mess to all residents using the back gate exit, the lake will not be accessible to 75% of the boaters, depending on the season the work is performed thus causing delays to all events for a boating/ fishing season, the cost of the operation is high due to the high cost of transportation, setup / removal of construction equipment, diversion of water during construction, potential damage to the existing docks, money paid to the contractor must be paid in large milestone payments – the Lake must borrow the money (which the covenants disallow) or we must save up to pay the contractor. This operation could take 6 or more months and the cost could exceed \$1 MM. This is a lot of money to pay for a small quantity of material to be removed. The lake assessment will increase \$600 per member per year to pay for the costs of an operation of this type every 8 years assuming an estimated \$1 million dollars.
    - **Advantages** - Ability to remove all silt from an area.

**WRWSD Board of Trustees Monday Meeting – 10/26/2020**

President Bridges called the meeting to order at 7:00 pm.

**Roll Call:** Present: Beard, Bridges, Buskey, Hagen, Levermore, Redick, Mgr. Cahall, Supt. Culver  
Absent: LaPlante (ex.)

**Minutes:** A motion was made by Hagen and seconded by Levermore to approve the 10/10/20 WRWSD meeting minutes as distributed by email. A yea/nay vote was taken and the motion passed unanimously.

**President's Report** (Jim Bridges): None

**Treasurer's Report** (John Buskey): Treasurer Buskey had several updates.

- ◆ There are two CDs coming to maturity. One is the legal CD in the amount of \$17,800. This will be rolled over for one year. The second CD is the sewer assessment CD in the amount of \$55,750. This CD will be rolled over for three years.
- ◆ Treasurer Buskey and Mgr. Cahall have been working on the WPOA and WRWSD contract for 2021. The contract is expected to increase by \$38,000 due to increased health insurance premiums, \$20,000 in salary increases which amounts to a 3% across the board cost of living adjustment and the higher salary for the Class 1 Sewer Operator position. It appears inevitable that there will be an increase to the water and sewer fees. The estimated monthly fee increase will be \$1-1.50 for each.
- ◆ Treasurer Buskey and Supt. Culver will be reviewing the water and sewer tap installation fees and grinder pump installation fees. The cost for each continues to rise.
- ◆ Sometime in November or December, the WRWSD budget will need to be readjusted due to several line items that have exceeded the projected amount.
- ◆ Treasurer Buskey reviewed the Oakwood Survey which is a publication of a town in Dayton that compares area water and sewer fees. He found that we are in line with our water and sewer fees.

**Manager and Plant Superintendent Report** (Paul Cahall & Supt. Culver):

- ◆ The water tower work is continuing. The pressure washing and scraping is almost complete. Several holes were identified in the overflow lines. Mgr. Cahall is getting an estimate for repair. The inside of the bowl will be drained and waxed once the outside worked has been finished.
- ◆ Maintenance on the fire hydrants continues. Lake Waynoka currently has 170 hydrants. Each one is being taken apart and working grease into all the components. There are roughly 40 hydrants left to complete.
- ◆ The upland reservoir is filling.
- ◆ The lagoon will be drained sometime after November 15<sup>th</sup>. We need to have a few freezes for the solids and the
- ◆ WPOA is still dredging. Please plan appropriately to remove your boat. The Board discussed budgeting 500 midge eating fish to be added yearly and everyone was in agreement.
- ◆ The WRWSD continues to search for a Class 1 Operator. There were several applicants although none met the criteria. Supt. Culver explained that the southwest Ohio region has a shortage of qualified personnel. The Board discussed the possibility of training staff within to take the exam to fulfill the position.
- ◆ Several leaks have been identified and are being addressed.
- ◆ The Bobcat UTV broke down and is being fixed. It is under warranty and has been a nice addition for the WRWSD staff.
- ◆ The charger for the generator stopped working. A replacement has been located and is expected to be in service by the end of the week.
- ◆ Copper and lead testing has been completed. The report came back stating that no lead whatsoever was found in the water. The EPA approved WRWSD for a three year cycle. The next testing will be completed in 2022.

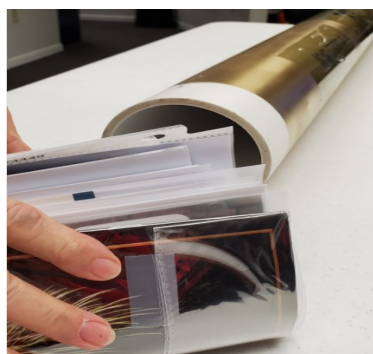
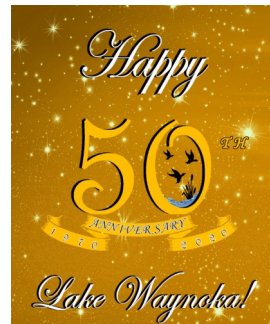
The Lake Waynoka 50<sup>th</sup> Anniversary time capsule has been buried now, located near the administration office/ front entrance area.

*Thank you to everyone for the memories that have made our 50<sup>th</sup> Anniversary celebration at Lake Waynoka so special all year.*

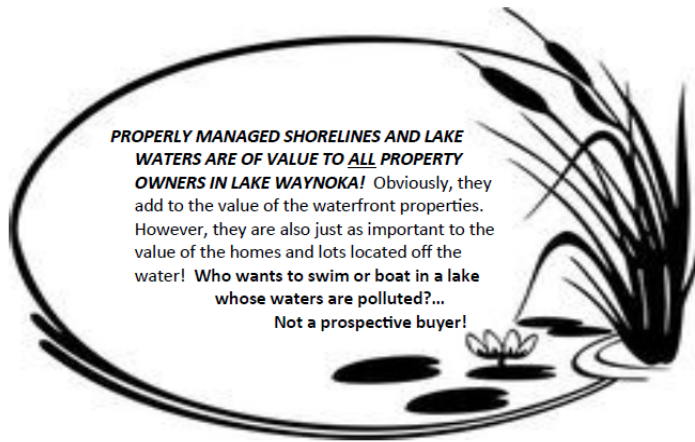

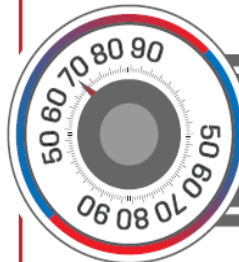
