2021 DOCK RENTAL

REMINDER

If you **LIKE** the dock you have this year and would like to have it again next year, between **April 1st, 2021 and December 15th, 2021**(no exceptions), either call or come into the Administration Office and pay the **\$50.00 NON-REFUNDABLE** reservation fee, otherwise, your dock will go into the dock lottery.

Between **January 1st, 2022 and March 15th, 2022**(no exceptions) you **MUST** pay the annual rental fee of **\$250.00**, or your dock will go into the dock lottery. You can not pay for your dock a full year in advance!

If you do not like your dock this year, you can sign up for the dock lottery, starting **March 1st, 2022**. The lottery will be drawn **April 1st, 8 am**, at the Administration Office, and you must be present to receive a dock.

WPOA Board of Trustees Saturday Meeting – 9/11/2021

***The deadline for submission of information for the monthly newsletter and other media releases is the Tuesday following the WPOA meeting at 4pm. The Office staff appreciates the cooperation of all of the clubs to share the events and activities held at Lake Waynoka.*

President Beard called the meeting to order at 10:02am.

Trustee Purdin led the attendees in the Lord's Prayer followed by the Pledge of Allegiance. In observance of September 11th, Mgr. Cahall shared a moving story of his time in the military during September 11th, 2001 and the events after.

Roll Call: Present: Barton, Beard, Ellis, Purdin, Raleigh, Taylor, Mgr. Cahall
Absent: Crank (ex) and Holt

Minutes:

- ◆ Raleigh made a motion and Barton seconded to approve the 8/14/21 minutes as printed in the newsletter. A yea/nay vote was taken and the motion passed unanimously.
- ◆ Purdin made a motion and Barton seconded to approve the 9/7/21 Special Meeting minutes as emailed. A yea/nay vote was taken and the motion passed unanimously.

President's Report (Charlie Beard): During the Special Meeting on September 7th, the Board elected Sean Moore to fulfill the remainder of former Trustee Von Wahle's term. Unfortunately, Mr. Moore is in quarantine and unable to be present today. He will take the Oath of Office at next month's meeting.

Treasurer's Report (Vern Taylor):

Operating funds

- ◆ The total operating income for the month of August was \$108,000.00.
- ◆ The total operating expense for the month of August was \$194,000.00 with no unexpected expenses.
- ◆ The operating fund balance at the end of August was \$1,121,659.85.
- ◆ The operating income for the year at the end of August was \$1,944,000.00 and that is 84% of the plan for 2021. The expected income at the end of August was 83% so the WPOA is 1% over budget.
- ◆ The operating expense for the year at the end of August was \$1,517,000.00 and that is 67% of the plan for 2021. The expected expense was 69% so we are 2% under budget.

Allocated Assessment Funds

- ◆ The income for allocated operating assessments in August was \$20,000.00.
- ◆ Assessment account expenditures in August totaled \$136,000.00. Almost all paving.
- ◆ The balance of all allocated assessment accounts at the end of August was \$798,088.43.

Invested Funds

- ◆ Invested reserves at the end of August totaled \$514,043.19.
- Total cash on hand at the end of July was \$2,651,741.80.

Manager's Report (Paul Cahall):

- ◆ We have continued with treatments for weeds and algae from Aqua Doc. They have been doing these treatments as often and to the extent that is safe to do. We expect to sign another contract with them for next year. We continue to work on a longer-term solution. These treatments can only kill what is there they do not prevent it from coming back and will not eliminate the issue completely. These treatments are done to keep the issue as under control as possible.
- ◆ The M.A.D. Scientist, that did in depth look at the health of the lake back in 2011, were back out on our lake on the 18th of August. We are expecting a preliminary report from them in mid-September and hopefully will be able to share their findings and recommendations at next month's meeting.
- ◆ Road paving has been completed. They will be back to chip and seal the marina and beach parking lots in the next couple of weeks.
- ◆ The dredging crews are back out there working. Please remember if you encounter one of the barge boats to give them plenty of room. The barges are very heavy and do not stop or change direction easily.
- ◆ The engineers have submitted the drawings to ODNR for the proposed repairs to the spillway at the dam. ODNR has responded and asked for some changes to the plans. The engineers will make those changes and resubmit the plan.
- ◆ We have signed a contract to have the new full court basketball court in the campground done in concrete. We were able to change to concrete for an additional \$2,000 and it will last much longer than asphalt.
- ◆ The Board has authorized a repair to the roof of the Recreation Center that will eliminate the condensation issues we have every winter. This repair will require the Rec Center to be closed for about a week in October to do the work. When we know the dates the Rec Center will be closed we will be posting them. The cost for this repair is about \$65,000.00.
- ◆ Online bill pay for water bills is active and can be used by logging into the member's only section. This area will be expanding in the future so watch for updates.

Other News from Security

- ◆ During the Month of August, officers took 3 reports, issued 2 traffic citations, issued criminal summonses reference a marijuana and drug paraphernalia seizure from a traffic stop and started a felony investigation in reference to suspected methamphetamine found in a vehicle that was towed from the community.
- ◆ The Lake Waynoka Police Department was invited to participate in the Brown County Major Crimes and Drug Task Force Annual Marijuana Eradication operation. This year, a flyover of the community was performed, approximately 200 plants were seized in Brown County, and 3 criminal cases were started by the task force.
- ◆ Marine Patrol conducted 80 hours of patrol during the month of August, 2 warnings were given for expired decals, 3 complaints for loud music, towed 2 boats, issued 9 warnings for “no wake “violations, 2 warnings for not having a spotter, 4 warnings for “ too fast after dark” responded to 8 calls for service. 3 fish baskets were checked.

Election Inspectors/Nominating (Margi Borgman/Dave Patton/Nan McHugh, Nominating Chairperson):

- ◆ In compliance with the Code of Regulations, Article IV, the Board will approve the following timeline for the 2021 Board elections at the September 11 meeting.
- ◆ Candidate applications must be received at the Administration office by 4 pm, Monday, September 27.
- ◆ Lists of eligible voters will be printed Monday, October 25 (All dues, water charges and fines must be paid by this date to be eligible to vote).
- ◆ Ballots will be mailed to voters by Wednesday, October 27.
- ◆ Returned ballots must be received at the Administration office by 4 pm, Monday, November 29.
- ◆ Votes will be counted by Friday, December 3.
- ◆ The candidate applications for WPOA and WRWSD Board of Trustees elections are available in the Administration Office and on the Lake Waynoka website. These positions are for the 2022-2024 term. Applications must be completed and returned to the Administration Office by the deadline of Monday, September 27, 2021, by 4 pm.

Long Range Planning Committee (Terry Borgman/John Barton):

1. The committee continues to monitor changes in the 5-year plan. When WPOA board decides what community decisions may be made, those decisions will be input as an update to the 2021 update due in September. The committee, Treasurer and General Manager monitor these costs periodically.
2. The committee has completed the work group meeting for the feasibility of the LODGE. We held four sessions, reviewing the functionality, the technical and location aspects of the Lodge portion of the building.
3. The committee started and completed the feasibility of the LOUNGE. We held two sessions also reviewing the functionality, the technical and location aspects of the lounge. We have collected information from the focus groups and reviewed these community comments to determine the potential wants that the board might consider for the 5-year plan. The evaluation research precedes a decision to remodel or rebuild the various buildings included in the 5- and 30-year plans. This is a study, not a decision.
4. The committee started the feasibility of the restaurant and kitchen portion of the lodge building in August.
5. The information and research discussed by the Work Group members have been open and revealing. The committee is ensuring that an open dialogue takes place during all meetings. We thank all the participants in the focus and work group meetings for the volunteer time they spent with the committee.
6. The information will be assembled in September of 2021.

New Business: There will be a citation review after the meeting.

Motions and Resolutions: Motion #334 was made by Holt and seconded by Barton. It is moved to increase the road repair budget by another \$20,000.00 to complete needed repairs around the lake. This additional amount will come from the road capital account. A roll call vote was taken and the motion passed unanimously.

WRWSD Board of Trustees Saturday Meeting – 9/11/2021

President Redick called the meeting to order at 9:30am. She welcomed everyone and asked for a moment of silence for those we lost and those who survived September 11th.

Roll Call: Present: Beard, Buskey, Hagen, Laplante, P. Levermore, S. Levermore, Redick, Mgr. Cahall

Minutes: A motion was made by P. Levermore and seconded by Beard to approve the 8/30/21 minutes as emailed. A yea/nay vote was taken and the motion passed unanimously.

President's Report (Redick): None

Treasurer's Report (John Buskey): We are roughly 2/3 of the way through the year and our income is up from 75% to 82%. This is due to greater bond income, 24 new residence permits and increased water income through the Auditor certifications.

Manager and Plant Superintendent Report (Paul Cahall):

- ◆ We had our exit meeting with the Auditor and asked about budgeting clarifications. It had to do with Capitol budgeting. We will take the recommendations and adjust accordingly.
- ◆ Supt. Culver has been out with a severe case of Covid for the past three weeks.
- ◆ The grinder parts shipment was not received this past week. We now have an estimated delivery sometime in October, however, ten housing units were shipped. We will piece together taps from extra parts and will replace with new parts once they are received.
- ◆ The work on the inside of the water tower began last week thanks to the cooler temperatures. They are expected to be finished on Monday.
- ◆ We have been on Brown County water for the past three weeks. We switched over when the new flooring was installed in the WRWSD office and lab. We have not switched back because the water tower needed to be empty for internal repairs. We hope to switch back sometime on Monday when the workers are finished with the repairs of the water tower. Trustee LaPlante asked Mgr. Cahall what is the increased cost of using Brown County water. Mgr. Cahall responded that it depends on how much water we use but we usually get a good deal on the water cost when we have to use it.

If the above items are introduced into your system it could result in premature failure of the pump and require service. If the red light on the electric box is on it means the pump is not working properly. Please call **Security** if you see your light or your neighbors light on.

WRWSD Board of Trustees Monday Meeting – 8/30/2021

President Redick called the meeting to order at 6:00 pm.

Roll Call: Present: Beard, Buskey, Hagen, LaPlante (late), P. Levermore, S. Levermore, Redick, Mgr. Cahall
Absent: Supt. Culver (ex.)

Minutes: Buskey made a motion and Beard seconded to approve the 8/14/21 meeting minutes as emailed. A yea/nay vote was taken and the motion passed unanimously.

President's Report (Prescilla Redick): None

Treasurer's Report (John Buskey/S. Levermore):

- ◆ We received a payment from the Brown County Auditor in the amount of \$22,918.01 for certified assessments. Of that amount, \$7,151.90 was for sewer recovery and \$15,766.11 was for water recovery.
- ◆ We satisfied our contract with the WPOA in the amount of \$19,957.94 for last year.
- ◆ We had three new water taps and three new sewer taps in July.
- ◆ We have requested a meeting with the Auditor to discuss their suggested budgeting system to determine what they mean and if we have to change our current procedure.

Manager and Plant Superintendent Report (Paul Cahall & Supt. Culver):

- ◆ The Online Pay option is active. It is accessible through the Lake Waynoka website. So far only a few people are using it to pay their water and sewer fees.
- ◆ Work on the water tower continues. The waxing of the inside of the tower will need to be rescheduled due to the high temperatures.
- ◆ The new flooring has been installed in the WRWSD office and lab. We will be adding kick plates and new paint soon.
- ◆ Grinder and tap parts are still an issue. We hope to receive our order on 9/2. We have 4-5 grinders waiting to be installed.
- ◆ Mgr. Cahall suggested that the new WRWSD truck be held off until next year due to lack of inventory. The Board agreed.
- ◆ Campground Fire Hydrant - **4/29/19** - The Board was joined by representatives from the Russelleville and Sardinia Fire Departments to gather information about their needs/suggestions for installing a fire hydrant in the campground. **5/20/19** - Information from a number of sources is still being gathered concerning a fire hydrant in the campground. **8/26/19** - Trustee LaPlante asked for an update about the campground fire hydrant. Mgr. Cahall stated that we are waiting for recommendations from WPOA Trustees Robinson and Crank plus two fire chiefs concerning the placement of the fire hydrant. The recommendations will be given to the WPOA Board for consideration and approval. The WRWSD will then be informed of any needs.
- ◆ We did not receive the State Auditor Award again this year. The ding was the absence of information concerning an Executive Session from last year.

Old Business: None

New Business: None

Motions and Resolutions: Motion # 2021- 09 was made by S. Levermore and seconded by P. Levermore to approve the following 2021 Budget amendments: income \$1,250,549.00, expenses \$1,305,474.00 and net income -\$54,925.

Board Member Concerns: P. Levermore was asked by a member of the community to inquire about water and sewer lines that go across the dam and if they can be shut off. Mgr. Cahall said the lines have shut off valves installed so we can turn them off if necessary.

Executive Session:

- ◆ At 6:17pm, S. Levermore motioned and P. Levermore seconded to move to Executive Session to discuss a personnel issue. A yea/nay vote was taken and the motion passed unanimously.
- ◆ At 6:32pm, P. Levermore motioned and LaPlante seconded to exit Executive Session. A yea/nay vote was taken and the motion passed unanimously.

Adjournment: The motion to adjourn was made by Hagen and seconded by LaPlante. All were in favor and the meeting was adjourned at 6:33pm.

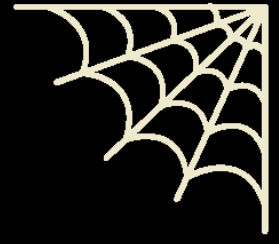

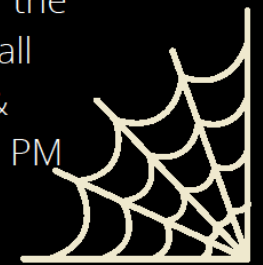

The WPOA Board of Trustees would like to thank all those who submitted applications for the vacant position. There were many qualified applicants to choose from. **Below is Mr. Moore's board application statement.**

My wife Stacy and I are home owners and have owned property at the lake since 2019. I graduated high school in 1992 and served in the Army Reserves 1993-1999. Currently I work for Hamilton County Public Health. I also do all the plumbing inspections for Brown County. Fortunately, I have had the privilege of being a plumbing volunteer for Habitat for Humanity, volunteer for Brown County 4H for 18 years, and a member of the Ohio Association Plumbing Institute. With my involvement in health related matters I think I have a unique prospective to help our community on some of these unchartered matters as we move forward. Please consider me for the vacant seat for the WPOA board. I would like to see that our community continues to grow and prosper and believe that I have the communication, and skill set to assist in this.

Managers Corner

Q: Why can't we buy passes for extended family members?

A: When you pay your annual dues you can see that it cost much more than \$15 per person per year to maintain the Lake Waynoka community. You can buy a Recreation Center pass for an extended family member that will get them in the gate and allow use of our facilities for \$200 per year per person.

Q: How do you determine what pot holes to fill, do we need to call and let you know where they are?

A: If you know where a particularly bad one is yes give us a call and we will put a priority on it. We use what is called cold mix to fill pot holes so we need the temperature to be at least 70 deg. for it to work well. We load a bunch of it on the back of the truck and start driving each road looking for and filling the pot holes. We try and do this as early in the year as we can and periodically check again during the summer.



Managers Reminder



- **To all lake front, and lake access properties**, there is a rule against purposely blowing your leaves into the lake. If we find a member doing this they can be fined \$50 per violation. Mother Nature puts plenty of leaves in the lake she doesn't need your help. Leaves go into the lake where the nutrients will feed unwanted algae growth next summer. In addition to the major "ick" factor, this algae is a problem because when it dies and decomposes at the bottom of the lake, it uses up oxygen that fish and native plants need. Also the association is spending thousands of dollars removing silt from the bottom of the lake and these leaves add to that project.
- **Contractors** do not sign contracts with the WPOA nor are any of them recommended or indorsed by the WPOA. When you have work done at your house make sure you know who you are dealing with and read the contract you are signing. If your contractor breaks Lake Waynoka rules you as the property owner are the only one the Association can hold responsible. This includes damage to water or sewer lines. If you feel that the contractor you have been working with has committed a criminal act such as fraud or theft contact the Lake Waynoka Police Department.
- **Property owners responsible for building permits** – Do not let any construction begin on your property unless you physically have a approved building permit. Do not take the word of the contractor that everything is in place. If construction is started before a permit is approved, you will be fined a minimum of \$50.
- **To property owners about guests** – Property owners please remember that your guests are not allowed to use Lake Waynoka facilities without yourself or a responsible member of your family with them.

Members are reminded that if their guests show up without being called in, they will not be admitted to the Lake. Also, it is not our responsibility to, nor will we, provide such a guest with your phone number. The guards will not call your home for your guests. Their job is to try and make sure unauthorized persons do not enter the Lake, it is not to make arrangements for you or your guests.

- **Building permits** – Please read the Building Code before starting any projects. Certain specifications are required and building permits are necessary. If you are in doubt whether a permit is needed for your project, please call the lake office for further information. The building Code can be found on the Lake Waynoka web site.
- **Controlled Burns** – Controlled burns are for yard waste only. No other household waste is permitted to be burned and Lake Waynoka. You must call the front gate and inform them you are having a controlled burn prior to burning. You must also stay present until the fire is completely out. 1st offense is a warning. 2nd offense is a \$50 fine.
- **Trading in your vehicle for another vehicle or replacing a windshield** – Please remember to remove your Lake Waynoka sticker from your windshield . If you don't you just gave access to our community to someone you don't know.

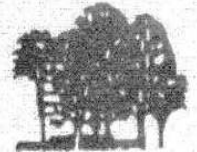

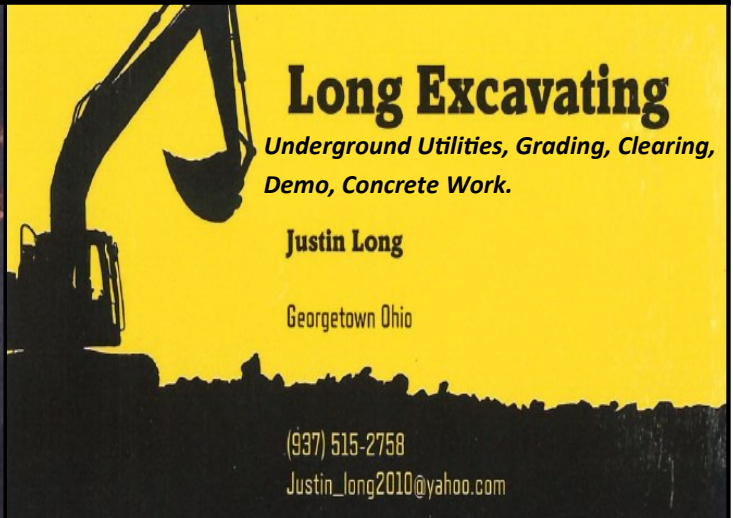
