WPOA Board of Trustees Saturday Meeting – 02/11/2023

***Any updates from the Friday email are indicated in **italics** of the summary of each report.*

***The deadline for submission of information for the monthly newsletter and other media releases is the Tuesday following the WPOA meeting at 4pm. The Office staff appreciates the cooperation of all of the clubs to share the events and activities held at Lake Waynoka.*

President Beard called the meeting to order at 10:00am.

Vice President Ellis led the attendees in the Lord's Prayer followed by the Pledge of Allegiance.

Roll Call : Present: Barton, Beard, Ellis, Holt, Marck, Taylor

Absent: Crank, Moore, Raleigh and Mgr. Cahall. All were excused.

Minutes : Taylor made a motion and Barton seconded to approve the 1/14/23 minutes as printed in the newsletter. A yea/nay vote was taken and the motion passed unanimously.

President's Report (Charlie Beard): A few members of the Board met with the Russellville Fire department representatives and the Jackson Township Trustees to discuss a new fire gate proposal in the amount of \$5,100. The Township stated they will not pay for the new gate nor will the Civic Club.

Treasurer's Report (Vern Taylor):

Operating funds

- January total operating income was \$209,000.00.
- January total operating expenses were \$200,000.00 with no unexpected expenses.
- Operating fund balance at the end of January was \$511,020.87.
- Operating income for the year at the end of January was \$209,000.00. That is 8% of the plan for 2023. Expected income at the end of January was 5% so 3% over budget.
- Operating expense for the year at the end of January was \$200,000.00. That is 8% of the plan for 2023. Expected expense at the end of January was 8% so right on budget.

Allocated Assessment Funds

- Income for allocated operating assessments in January were \$90,000.00
- Assessment account expenditures in January totaled \$10,000.00
- Balance of all allocated assessment accounts at the end of January were \$978,802.87.

Invested Funds

- Invested reserves at the end of January totaled \$515,559.69.
 - * Total cash on hand at the end of January was \$2,005,383.43.

Manager's Report (Paul Cahall):

- Spectrum has updated our systems from the change from Bryer Cable. All of phones and internet connection are now working properly.
- We had planned to bring the lake down 5 to 7 feet this winter for dock and shoreline work. The Valve has been open since late November and should remain open until about mid-February. Mother nature again is not helping us with this process but we are doing all we can without putting early boating season in jeopardy.
- The work on the drainage issues in the campground continues. They have come in and cleaned out all blockages out of and inspected all drainage lines. Work will continue along with a long-range recommendation from the engineer.
- Repairs on the lodge continue after the waterline busting. Most of these repairs are covered under our insurance and should be completed by the end of February. Maintenance has been taking advantage of the time by doing other upgrades needed in the restaurant area. Some delays have occurred because of insurance vs contractor negotiations.
- Maintenance continues to work on ditching and clearing the roadsides of brush and obstructions.
- A committee of the board, Jackson Township Trustees and representatives from Russellville Fire department had a meeting to discuss the fire gate and negotiations continue.

Rules and Regulations (Greg Stover/Pat Raleigh): At the request of the WPOA Board of Trustees the Rules and Regulations Committee over the past several months has been reviewing the Fine Schedule found in the Lake Waynoka General Rules and Regulations, Volume 1, page 21. Our review has included:

- The individual schedules within the Fine Schedule, as well as the level of fines and other penalties defined in the Fine Schedule.
- A process of creating a master list of all violations defined in Volume 1 along with their associated fine or penalty.
- Review of several legal articles regarding the purpose and level of fines and other penalties, and legal implications.
- Contact with several other lake communities, and small communities to explore best practices.

We are currently developing a report for presentation to the WPOA Board, including recommendations regard the level of fines and penalties for violations and how they are categorized. These will be reviewed with the Chief of the Lake Waynoka Rangers and the General Manager, who bear primary responsibility for enforcement, before submission to the Trustees.

Campground Committee (Ken Crank/Carrie Paul): None.

Unfinished Business: None.

New Business: A variance was submitted by lot #2833 for a 4' x 12' dig out for a boat slip. A motion was made by Taylor and seconded by Barton to approve the request. A yea/nay vote was taken and the motion passed unanimously.

Motions & Resolutions: Variance (Please see New Business).

Community Organizations:

- Civic Club (Michael LaPlante) – Bingo tonight.
- Chapel (Valerie Bullock) – Sunday services at 10am and Thursday night at 6pm for Bible and children's studies.
- Shawnee Women's Club (Margi Borgman) – We meet the first Monday of every month at 10am. We will be hosting an Easter Egg Hunt on April 1st with a rain date of April 2nd. Registration begins at 12:30 with a 1:10 start. We will be staggering the starts according to age groups. We are accepting donations of non-chocolate wrapped candies. If anyone has a special needs child, please let us know beforehand so we can make accommodations. We will be sponsoring the Ice Cream Social and Rubber Duck Regatta again this year. It will be at the pool on May 26th with a rain date of May 27th. We will be selling 300 ducks this year at a cost of \$5.00 per duck. All clubs are invited to set up a table to let folks know of their upcoming activities and events.
- Art Club (Joanne Edwards) – We will be hosting fundraisers to continue our work at Destination Park. I am selling Uncorked on Canvas tickets. We will only have 30 tickets for sake at a cost of \$30/ea. The event is on March 18th at 6pm. We have fun events scheduled in March and April on the first Monday of the month at 10am where we will be learning new techniques.

Board Comments and Concerns: None.

Membership Compliments and Concerns:

- Doris Kitchen expressed her concerns about the fire gate issue and the safety of members. There is a lock on the gate and emergency personnel need to have access to respond to calls. She said the Russelleville Fire/EMS department presented a proposal in the amount of \$5,100 for a solar powered gate with a keypad entry. She doesn't understand why the WPOA won't pay for the gate. This began a series of conversations between Ms. Kitchen, Treasurer Taylor and Trustee Holt. They said there is much more information to gather. How reliable is a solar operated gate? Should we have generator backup in the event of failure from the solar powered gate which would include the expense of running electricity and purchasing/installing a generator? This could drive the cost up to \$50,000-70,000. How many times was the gate used? Was it for entrances or exits? Which place responded? Does the WPOA or WRWSD own the lot that the gate is on? Is fundraising an option to help with the cost? Can we get a group of Jackson Township property owners to go to Township meeting and present their concerns? Maintenance Supervisor Chadwell said that maintenance will begin work on widening the entrance to the fire gate and bring the gate in about 35 ft. so responders will be able to pull off Martin Alexander. Jackson Township paid for the culvert. John Manning from the Russelleville Fire/EMS said four volunteers live at the lake and he would like everyone to get together and find a viable solution. The Board received the new proposal a few weeks ago and need to gather all the facts concerning the fire gate while maintaining community safety.
- Valerie Bullock echoed Ms. Kitchen's concerns about the fire gate and would like to see the WPOA fund the \$5,100 for the new fire gate. She also asked for an update about the Lodge. Mgr. Cahall will provide more information when he returns from vacation.

Adjournment: The motion to adjourn was made by Taylor and seconded by Crank. A yea/nay vote was taken. All were in favor and the meeting was adjourned at 10:14am.

WRWSD Board of Trustees Saturday Meeting – 02/11/2023

President P. Levermore called the meeting to order at 9:30am.

Roll Call: Present: Armstrong, Buskey, LaPlante, P. Levermore, S. Levermore, Wales
Absent: Moore and Cahall. Both were excused.

Minutes: A motion was made by Buskey and seconded by LaPlante to approve the 1/30/23 minutes as read. A yea/nay vote was taken and the motion passed unanimously.

President's Report (P. Levermore): None.

Treasurer's Report (S. Levermore): Our income is tracking fine and our expenses are a bit high due to the additional Required EPA testing and supplies. We will be adjusting the budget accordingly to accommodate the costs.

Manager and Plant Superintendent Report (Paul Cahall):

- We started phase one of the hydrant flushing and evaluation this past Wednesday. The two broken hydrants are being repaired first then we will be checking/flushing all the hydrants around Waynoka (approx 40). Then they will probably be doing Sitting Bull and Horse Shoe. A notice has been posted and we are expecting this phase to take around 30 days to complete.
- We are still working on the carbon filter material. We hope to know more by the end of next week.
- We are in the process of interviewing people for the open positions at the plant. The new guy left for another job.
- Everything else seems to be running smoothly.

Old Business: Trustee Buskey spoke with Supt. Pike about repair of the meter near the plant. He believes the repair will cost \$200-300 vs. replacing the meter at a cost of \$6,000.

New Business: None.

Motions and Resolutions:

- A motion was made by LaPlante and seconded by Armstrong to approve the January 31st financial statement as distributed. A yea/nay vote was taken and the motion passed unanimously.
- Motion #2023-06 was made by LaPlante and seconded by Armstrong to amend 2023 WRWSD Budget expenses by \$4,600.00 to a total expense of \$1543471.00. A roll call vote was taken and the motion passed unanimously.

Board Member Concerns: None.

Membership Concerns: None.

Adjournment: The motion to adjourn was made by Buskey and seconded by LaPlante. A yea/nay vote was taken. All were in favor and the meeting was adjourned at 9:45am.

WRWSD Board of Trustees Monday Meeting – 01/30/2023

President P. Levermore called the meeting to order at 6:00pm.

Roll Call: Present: Armstrong, Buskey, LaPlante, P. Levermore, S. Levermore, Moore, Wales, Mgr. Cahall, Supt. Pike

Minutes: A motion was made by LaPlante and seconded by Buskey to approve the 1/14/23 Monthly Meeting minutes as distributed. A ye/nay vote was taken and the motion passed unanimously.

President's Report (P. Levermore):

- President P. Levermore distributed a calendar draft of the 2023 and the beginning of 2024 meetings.
- There has been some questioning about the decision to keep producing our own water versus permanently going to Brown County Rural Water (BCRW). While this information has been previously covered (see minutes 11/28/2022), since BCRW has announced their new rates in December, we feel it is helpful to restate and update the data which has led the board to their decision.

Per BCRW Dec 10, 2022 letter, their average monthly residential usage is 3,700 gallons.

BCRW - first 2,000 gallons is \$26.50

BCRW - up to each additional 1,000 gallons \$7.65

BCRW - average monthly bill (3,700 gallons) is \$41.80

WRWSD - first 3,000 gallons is \$26.50

WRWSD - up to each additional 1,000 gallons \$9.00

WRWSD monthly bill for 3,700 gallons is \$35.50

So at BCRW average usage, the monthly expense for BCRW is more than \$6 above, or 17% more, than the comparable WRWSD expense. Note: Neither of these include any sanitary/sewer costs. To re-emphasize information also previously covered, the water plant could, if need be, significantly increase (at least double) the amount of water it produces by just increasing hours of operation in which we pump from the reservoir. The existing plant is capable of handling this. To increase capacity on the sewer side is significantly more involved and would therefore require a significant investment, but this point is a non-factor when it comes to looking at BCRW vs WRWSD water.

Treasurer's Report (S. Levermore):

- We have a few items that were finished in 2022 but needed to be budgeted for in 2023. One is the effluent monitor and the second is the Brown County water invoice that was expected in December but did not arrive until after the first of the year. The budget was amended.
- Mgr. Cahall said the State Auditor changed the way they look at things. The budget used to be adjusted quarterly but the Auditors want the adjustments made monthly before any checks can be written so the Board can expect more motions this year to keep everything up to date.
- We have one new home permit this year and a few homes already under construction.
- Several motions were made. *Please see Motions & Resolutions below.*

Manager and Plant Superintendent Report (Paul Cahall & Supt. Pike):

- The lagoon valve is closed. We will open it for a few weeks in April. Mgr. Cahall told the Board that they will need to adjust the sewer expenses in a few months to cover expenses required by the EPA such as, more frequent testing, a more detailed test of metals and the addition of outside lab testing once a week.
- The plant gate is not finished yet. The company will be out this week to resume work on it. Once that is complete, we will begin installing the cameras.
- The new UTV arrived. It is a heavy-duty diesel Kubota. We sold the old one to the WPOA.
- Filters – We are waiting to hear about the old carbon we sent out several years ago. It was to be refired and stored for us. The company cannot seem locate it. Mgr. Cahall said they will have to replace what was lost.
- CT consultants – The EPA wants a detailed floor plan of the water plant. CT Consultants is working on a proposal.
- Fire Hydrants – We have signed a contract for someone to test 30% (60) of our fire hydrants and repair any that are broken. We will then decide if we want to contract more or have our team work on the others. Supt. Pike said that a new hydrant is roughly \$4,000 compared to \$1,000 to rebuild one. Trustee Moore reminded Mgr. Cahall and Supt. Pike to get the word out to residents in the area where testing will be performed.
- Trustee Buskey asked about the ordering of new equipment and if it has been installed. Everything is newly installed and is working good.
- Trustee Buskey asked about a meter at the water plant not working. Supt. Pike said the meter can be read manually and that he believes a wire is not connected properly to allow it to be read electronically. He will look into it.

Old Business: None.

New Business: President P. Levermore said that we've been intentionally limiting our reserve contributions and asked how we intend to replace those funds especially since there may be a required sewer plant expansion in the coming years. Treasurer S. Levermore said that there will be budget corrections made in the next few years. Trustee Buskey stated that the WRWSD has a good credit rating and is eligible for low interest grants and loans. The RACP can help with seeking grants. There are a lot of good options moving forward when the sewer expansion is needed.

Motions and Resolutions:

- Motion #2023-02 was made by LaPlante and seconded by Moore to certify the following beginning balances for 2023. Total Checking/Savings \$2,271,685.95. A roll call vote was taken and the motion passed unanimously.
- Motion #2023-03 was made by Buskey and seconded by Wales to certify the following receipts for revenue. \$1,311,029.00. A roll call vote was taken and the motion passed unanimously.
- Motion #2023-04 was made by Moore and seconded by Armstrong to adopt the following appropriations for estimated expenditures as of January 1 2023. Total expense \$1,493,665.00. A roll call vote was taken and the motion passed unanimously.
- Motion #2023-05 was made by Laplante and seconded by Buskey to move \$25,000.00 from water reserves to water operating. A roll call vote was taken and the motion passed unanimously.

Board Member Concerns:

- Trustee Moore asked about the painting of the water tower. Mgr. Cahall said we will have to hire another company to complete the job.
- Trustee Wales suggested scheduling a water plant tour for the community so members can tour the plant and look at all the updates. Trustee Buskey agreed and said there was a tour many years ago and it was well received by the community. Mgr. Cahall and Supt. Pike believe a tour can be accommodated late spring or early summer. They will keep the Board updated so they will have time to advertise the event.
- Treasurer S. Levermore suggested we start researching electronic water bills. This would be an ongoing project to compare and discuss the pros and cons.

Adjournment: The motion to adjourn was made by LaPlante and seconded by Moore. A yea/nay vote was taken. All were in favor and the meeting was adjourned at 7:01pm.

IMPORTANT REMINDERS

RFID DECALS:

- If not renewed, RFID decals will stop working on May 1st, 2023 at 12:00 am.
- RFID decals will be able to be renewed any time after all 2023 dues and fees have been paid.
- It costs \$15/vehicle for RFID renewal, and \$25/vehicle for new RFID decals.
- You will not need to have your registration to renew a decal, just your membership card.
- Decals can be renewed at the security building or the administration office.
- Renewals at security building can only be done by cash or check.
- The administration office can renew RFID decals over the phone with credit cards.
- If you want to renew all RFID decals under your account at one time, it must be done at the administration office. • You must have the membership card the vehicle is registered under to renew a decal at the security building.

BOAT DOCK RENTAL:

You can sign up for the dock lottery, starting March 1st, 2023 at our administration office. The lottery will be drawn April 3rd, 8 am, inside the lodge, and you must be present to receive a dock. Only owners and spouses are eligible, and all annual fees must be paid.

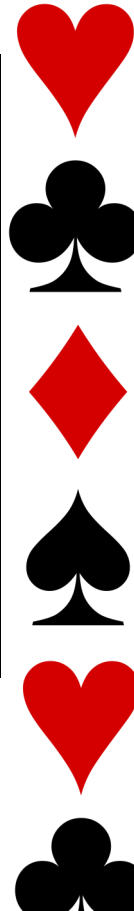

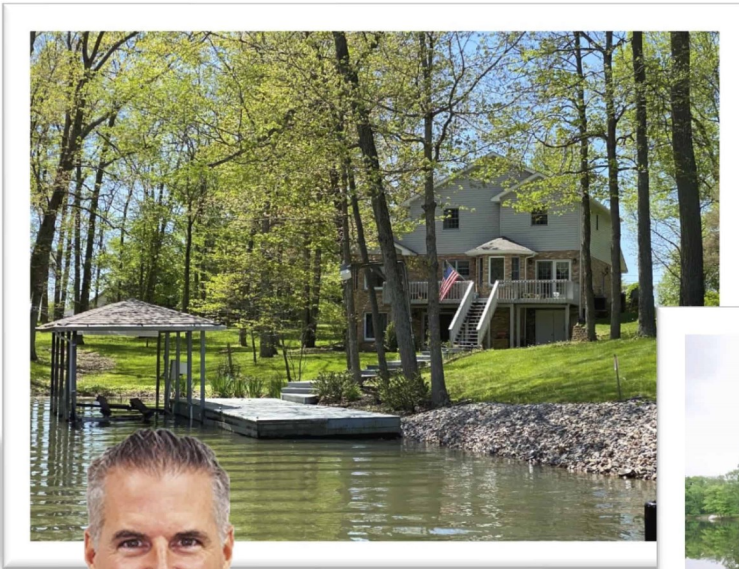
