## WPOA Board of Trustees Saturday Meeting – 10/14/2023

*\*\*Any updates from the Friday email are indicated in **italics** of the summary of each report.*

*\*\*The deadline for submission of information for the monthly newsletter and other media releases is the Tuesday following the WPOA meeting at 4pm. The Office staff appreciates the cooperation of all of the clubs to share the events and activities held at Lake Waynoka.*

President Ellis called the meeting to order at 10:03 am.

President Ellis led the attendees in the Lord's Prayer followed by the Pledge of Allegiance.

**Roll Call:** Present: Barton, Bynum, Eads, Ellis, Marck, Moore, Raleigh, Mgr. Cahall

Absent Taylor, Crank. Both were excused

**Minutes:** Raleigh made a motion and Barton seconded to approve the 9/9/23 WPOA Monthly minutes as printed in the newsletter. A yea/nay vote was taken and the motion passed unanimously.

**President's Report (Ellis):** A reminder that immediately following the meeting, the election committee will host a meet the candidate event and allow applicants to use 3 minutes to introduce themselves. Another reminder that members in good standing will be receiving a ballot and information letter in the mail. You will be selecting 3 candidates for Trustee and voting on the restrictive covenant change to allow borrowing for the new lodge proposal.

### **Treasurer's Report (Barton):**

#### **Operating funds**

- September total operating income was \$110,000.
- September total operating expenses were \$273,000.00 with no unexpected expenses.
- Operating fund balance at the end of September was \$779,416.39.
- Operating income for the year at the end of September was \$2,380,000.00. That is 87% of the plan for 2023. Expected income at the end of September was 87% so right on budget.
- Operating expense for the year at the end of September was \$2,038,000.00. That is 78% of the plan for 2023. Expected expense at the end of September was 77% so 1% over budget.

#### **Allocated Assessment Funds**

- Income for allocated operating assessments in September were \$8,000.00
- Assessment account expenditures in September totaled \$4,000.00.
- Balance of all allocated assessment accounts at the end of September were \$1,136,640.30.

#### **Invested Funds**

- Invested Reserves at the end of September totaled \$517,682.19.  
Total cash on hand at the end of September was \$2,433,738.88

*We are in the middle of budgeting for 2024 and are meeting once a week.*

### **Manager's Report (Paul Cahall):**

- October is budgeting month. The financial committee will be holding meetings all this month preparing an operations budget for the board's consideration. The proposed budget will be presented to the board at the November workshop meeting. Any changes required from the board will be made for a December vote for approval. We are also giving capital projects a hard look for next year.
- Dredging will continue until the end of October then the equipment will be removed from the lake to prepare for winter drawdown.
- Myself and a few board members attended the OLCA meeting held at Hidden Valley Lake. As always it was a great networking and education opportunity. The board will be reviewing information and opportunities from what was presented at the conference over the next several months.
- A reminder that if you plan to leave a pass for a guest to go to the Halloween event, we will not be accepting open passes on that day. We will need the name of your guest for them to get in. Everyday all non-members must have a pass called in for access but we do accept open passes from members for special events.
- I have been getting questions about lake lowering. Lake lowering will begin sometime after the 15th of November please ensure you have taken care of your boat by that time. The board has decided we will try and take the lake down 5 to 7 feet this winter for dock and shoreline work. If you were considering doing any of that type of work start working with your contractor now. Work completed or not the valve will be closed no later than 15 February.
- We are currently looking at bids for replacement of the roofs on the lounge, pool house, and the covered picnic area by the pool. These will be done matching the Recreation center roof.

**Election Inspectors/Nominating (Margi Borgman/Nan McHugh/Dawn McNees, Nominating Chairperson):** Applications from 9 candidates for the 2023 WPOA Board of Trustees election have been accepted. The candidates are: John Barton, Gary Dombroskie, Doris Kitchen, Nancee Klein, Chris Lane, Charles Miller M.D., Joan Pettigrew, David Wagner, and Nan Wales.

**Reminders:**

- In order to be eligible to vote you need to be in good standing so please make sure all your dues/fees are paid by October 24th.
- Also make sure the Admin office has your current address, we want everyone to be able to vote.
- Ballots will be mailed out to members in good standing on October 25th.
- After today's meeting and after the November WPOA monthly meeting each candidate is invited to use 3 minutes to introduce themselves and tell members why they should be considered a potential trustee.
- Also, the candidate's application statements will be included in the newsletter.
- *Margi Borgman announced that candidates for Trustee will be given 3 minutes to speak following today's meeting. There will be no questions taken from the floor. She also announced that per the Blue Book, no election signs are permitted within Lake Waynoka.*

**Lake Advisory (T. Redick/Jim Marck):** President Ellis stated that the Board has been meeting with the committee monthly and discussing multiple proposed recommendations. We will be bringing information to the community for feedback before any motions are made.

**Long Range Planning Committee (Terry Borgman/Pat Raleigh):** The Long Range Planning Committee has reviewed project work completed to date in 2023, comparing actual costs to budgeted costs. A) The Improvement Capital Assessment account has 62% of budgeted work completed. 1 – Lodge repairs to remediate water damage were completed. 2 – Reroofing the lounge, lodge and pool equipment building are to be completed. 3 – Salvage value was collected on 2 pieces of Maintenance equipment. B) Lake Capital Assessment account has 31% of budgeted work completed. 1 – Dredging work was delayed due to low water levels. Main channel dredging will continue until mid-November, weather permitting. C) Road Capital Assessment account has 98% of budgeted work completed. 1 – Running Bear culvert repair was completed with additional reserve funding provided by the WPOA Board. B) The LRPC, General Manager and WPOA Board have begun reviewing projects and capital assessment budgets for 2024, with awareness that funding must exceed expenses. Membership comments and suggestions that have been shared with the Board will be considered. 1 – Improvement Capital Assessment account under consideration for 2024: replacing card reader at security building, essential lodge repairs (roof, plumbing, foundation), scheduled interior lodge renovations. Rec Center: annual exercise equipment repairs, minor roof repairs, scheduled interior upgrades, replace gym floor. Outdoor Pool: cartridge filter replacements, scheduled furniture replacements. Maintenance equipment replacement (2000 GMC truck). B) Lake Capital Assessment account under consideration for 2024: annual lake maintenance, algae control, cove and main channel dredging, stocking fish, erosion control, dock replacements and repairs, sedimentation prevention program at Kiddie Corral. C) Roads Capital Assessment account under consideration for 2024: routine road paving upgrading to asphalt, saving for Waynoka Drive repaving project in 2029. *There has been lots of good conversations about future capital assessments. The committee is looking for ideas and projects. President Ellis thanked the committee for their hard work.*

**Rules and Regulations (John Buskey/Pat Raleigh):** The committee has completed revising and editing the General Rules & Regulations (Vol. 1) document (Yellow Book) and will be forwarding it this coming week to WPOA President Jenny Ellis for review by the Board. The focus on this revision, at the request of the Board, was to update the fine schedule and to add any motions passed by the Board since the last revision on May 9, 2020. John personally thanked the members of the committee for the dedicated and excellent work they did in working on the document. They include: Jeff Albrinck, Greg Stover, Tim Redick and Nan Wales.

**Campground Committee (Carrie Paul/Sue Eads):** Carrie said that the campground had a great summer. The old playground is being removed after the season. The committee is making plans for a new playground. Trick or Treat will be on October 21<sup>st</sup> from 5-6:30 followed by hayrides afterwards.

**Community Organizations:** Shawnee Women's Club – Margi Borgman – We meet the first Wednesday of the month in the Lodge. We will be hosting a Veteran's picnic on Wednesday. All Veterans are invited. We will have residents from the facility in Georgetown participating. Thank you to Maintenance for setting up for the event. The Holiday Extravaganza is October 21st from 9-3. This is an open gate event. All booths have been reserved. Light Up the Lake is scheduled for December 9th. More information to come.

**Board Comments and Concerns:** None

**Membership Compliments and Concerns:**

- Kim Kramer – asked for an update about replacing Red Cloud docks. Paul said they were scheduled to be replaced in 2028 but with the condition they are in, they are being considered for replacement in 2024.
- Rhonda Maybriar – asked everyone to use due diligence of Trustee candidates before casting their ballot.
- Ken Wagner – The lights at the pickleball courts need to be replaced so we can play outside longer. Secretary Barton said this is under consideration for the 2024 budget.
- Tom Wyatt is concerned about the direction of the lake. There has been no money set aside over the past several years for the lodge project. Voting yes essentially places a lien on your home. The growth and strength of the community should be based on the lake. Treasurer Barton said there are no liens placed on individual properties. There will be a yearly assessment. If you sell your home, the new owner takes over paying that assessment. He also stated that there has been LRPC money set aside for lodge upkeep. President Ellis asked everyone to read the informational sheet that will be included in your ballot.
- Kimberly Loucks addressed her concern about the speed of cars within the lake making it unsafe for pedestrians. She has noticed cars coming around curves on the wrong side of the road.

- Nancee Klein expressed her concerns about the growing population and the need for a sewer expansion in the coming years. She asked that the WPOA and WRWSD Boards work together so residents aren't hit with higher assessments from each entity.
- Carolynne Pennelope Swenson agreed that speed on the roads is a huge problem. She asked that the Board consider putting in speed humps to control speeding cars.
- John Buskey addressed Nancee's concerns and said the WRWSD has been saving money for the sewer expansion and is working closely with the EPA. He has been on the WRWSD Board since 2005 and Treasurer for 17 years until recently.

**Adjournment:** The motion to adjourn was made by Barton and seconded by Raleigh. A yea/nay vote was taken. All were in favor and the meeting was adjourned at 10:40am.

**Manager and Plant Superintendent Report (Paul Cahall/Dan Pike):**

- We will open the lagoon valve sometime after November 15<sup>th</sup> and it will remain open until the first of the year.
- We had an EPA sewer inspection. There were no violations found. The Inspector had a few recommendations. We are waiting on the final report.
- We received a second bid on the water tower and are waiting on a third. We will be discussing those bids at the next Monday night meeting.

**Motions and Resolutions:** A motion was made by Kost and seconded by Buskey to approve the September 30<sup>th</sup> financial statement as distributed. A yea/nay vote was taken and the motion passed unanimously.

**Membership Concerns:** Margie Borgman thanked the WRWSD staff on their quick response to a grinder issue at their home.

## WRWSD Board of Trustees Monday Meeting – 09/25/2023

President P. Levermore called the meeting to order at 6:00 pm.

**Roll Call:** Present: Kost, P. Levermore, S. Levermore, Wales, Mgr. Cahall, Supt. Pike

Absent: Armstrong, Buskey, Moore. All were excused.

**Minutes:** A motion was made by S. Levermore and seconded by Kost to approve the 9/9/23 Monthly Meeting minutes as distributed. A yea/nay vote was taken and the motion passed unanimously.

**President's Report (P. Levermore):** President P. Levermore sent a draft of why the lake is lowered each year for Trustees to review. He received feedback from Buskey, Cahall and Pike. The Board discussed the draft and made revisions, as necessary. The Board decided to move forward with posting the final document. Version #1 of the document will be sent out in the WPOA October email blast, handouts at the monthly meeting and a link posted on the website and in the newsletter. The document will be permanently posted on the WRWSD page under Documents for members to review. The Board hopes this will explain the rationale for lake lowering.

**Treasurer's Report (S. Levermore):**

- Treasurer S. Levermore passed around the general ledger for review.
- He discussed the line items to be amended for the 2023 Budget. *See Motions & Resolutions below.*
- He presented a copy of the initial 2024 budget to the Board for approval, as required by State Auditors, for the Board to review before voting on the motion. *See Motions & Resolutions below.*
- Treasurer S. Levermore attended the Grant Writing workshop and gave a report to the Board. There are several avenues to pursue to find grants and/or low interest loans. He found the information very helpful as we are moving towards expanding the sewer plant in the coming years. Secretary Wales has looked at the workshops available to the WRWSD and asked Mgr. Cahall if Supt. Pike and others in the WRWSD plant can attend. Mgr. Cahall said they are welcome to attend. Supt. Pike said that he needs educational credits to renew his license every two years and he does a number of educational courses each year.

**Manager and Plant Superintendent Report (Paul Cahall):**

- The asset management system is up and running. Greg Wilson is gathering data to enter into the system. Supt. Pike plans to train someone to help him keep up with work orders and to keep the system up to date.
- We are having issues getting quotes for the water tower. Most companies are booked out or find doing only one tower to be not worth their mobilization expense since they need to come from quite a distance away.
- We have a full staff at the WRWSD plant.
- Mgr. Cahall and Supt. Pike continue to reach out to the EPA about direct discharge information. Rick from the EPA said it is very hard to get direct discharge these days but he is sending it up the ladder.
- Supt. Pike went over the water loss report. We fixed a few leaks and everything is running well.
- Tina Taylor will receive public records training. *See Motions below.*
- Secretary Wales asked about keeping track of people who continually abuse their grinder pumps. Supt. Pike said it is documented, pictures taken and owners told they would have to pay for repairs should it continue. The Board would like to see a certified letter sent in the future for our records.

**Motions and Resolutions:**

- Motion #2023-19 was made by Kost and seconded by Wales to amend the 2023 WRWSD budget. A roll call vote was taken and the motion passed unanimously.
- Motion #2023-20 was made by Kost and seconded by S. Levermore to approve the attached 2024 budget with a total income of \$1,336,284.00 and a total expense of \$1,473,480.00. A roll call vote was taken and the motion passed unanimously.
- Motion #2023-21 was made by Wales and seconded by S. Levermore to move \$50,000 from water reserves to the water operating account. A roll call vote was taken and the motion passed unanimously.
- Motion #2023-22 was made by S. Levermore made a motion and Wales seconded to authorize Tina Taylor to receive public records training on behalf of the WRWSD Board of Trustees. A roll call vote was taken and the motion passed unanimously.

**Adjournment:** A motion was made by Wales and seconded by Kost to adjourn the meeting. A yea/nay vote was taken. All were in favor and the meeting was adjourned at 7:08pm.

## 2023 WPOA Board of Trustee Candidates



My name is John Barton and I am running for re-election to the WPOA Board. I have been a property owner and WPOA member since 2018. I am the past chairman of the Rules and Regs Committee and am the current Chairman of the Finance Committee, and serve as the WPOA Treasurer. I was elected to the WPOA Board in April 2021, so I have served about 2 ½ years. I am a lawyer and a CPA (inactive) and have worked in management in health care for close to 30 years. The two most important issues I see here at Lake Waynoka are the divisiveness in the community and lake management (preventing silt from entering the lake, silt removal, and lake health). I believe we could significantly reduce the divisiveness by creating a formal community plan that identifies and begins to address the community's long-term needs, and if I am re-elected I would vigorously pursue creating such a plan. I am already involved in two plans that were recommended by MAD Scientist Associates to deflect silt from entering the lake, and would continue to push these projects if re-elected. The Board is already in the process of re-examining the current silt removal plan and if re-elected I would continue my involvement in that process. I am absolutely willing to take an unpopular stance if I believe that decision is in the best interest of the community - I have done so recently on the marina point noise controversy. I see the Board's overriding role as balancing the needs of the "We" against the needs of the "Me".



Hello, my name is Gary Dombroskie. My wife Gibby and I have been property owners for 10+ years and full-time residents since July 2018. Our Lake Waynoka journey began in the summer of 2010 while visiting very close friends. We spent many weekends here and decided to buy our own place to call home. We were drawn to the lake primarily for three reasons: the water, the amenities and the people. This lake community is a hidden GEM! We've watched the lake grow, mostly for the good. As with any community, we have issues. As a WPOA Trustee, I will diligently work to resolve current and future issues. I understand the importance of fiscal responsibility and will ardently work ensuring our budget and plans align with property owner priorities. I have the experience and qualifications to help make Lake Waynoka an even better place to live. I served a total of 37 years in the United States Air Force; retiring as a LT Colonel from a 23-year activity duty career and a senior level Program Manager (PM) with 14-years civil service. Initially trained as a Navigator, I acquired the training/skills necessary to plan/organize/execute multiple world-wide operational and flight test missions accumulating 5,000+ flying hours. I firmly believe that effective leadership, transparency and community engagement are key to achieving shared goals in our beautiful lake community. Doris Kitchen. I have been a full time resident of this great community for over 18 years. My background includes over 25 years selling Real Estate in two gated Lake Communities. I was also a Kroger Store Manager for 10 years, and worked as an Assistant Manager and Manager of a Finance Company. Two issues that are so important to our community is our physical Lake, which is the reason most of us are living here. Our priorities should be the quality of our water, our dredging operation, and the safety of all boaters. We also need to re-evaluate our gated community policies. We need to truly be a gated community. I am committed to transparency, accountability, and fiscal responsibility. I believe that Trustees have an obligation to YOU the property owners. ### Dock Rental Policy

The following is the WPOA policy on annual dock rentals and how they will be handled to make the process as fair and covenant as possible for all members in good standing eligible to get a rental dock. This policy was approved by the WPOA board of Trustees in Motion 362 12 August 2023.

#### Who is eligible and who is not eligible for a rental dock:

1. Must be a member in good standing at the time of applying for a rental dock.
2. Cannot own a property that has a boat dock assigned to it.
3. Cannot rent more than one dock per owner.
4. WPOA owned rental docks cannot be sublet. Violations will result in loss of use of the dock and a \$100 fine.

#### If you already have a dock and want to keep it.

1. Must pay your reservation fee between April 16 and December 15<sup>th</sup> no exceptions. If you fail to pay this fee by 15 December your dock will go into the lottery held on April 15<sup>th</sup>.
2. Must pay your annual dock rental fee and all dues, assessments and fees between 1 January and 1 April no exceptions. Failure to meet this deadline will result in your dock going into the lottery held on April 15<sup>th</sup>.

#### How to get signed up for the lottery if you want a dock.

1. Sign up for the dock lottery will begin in the administrative building on the 1<sup>st</sup> of March.
2. You must be a member in good standing having paid all dues and fees for current year.
3. All dock lottery entries must be in by the close of business April 14<sup>th</sup>.

#### How Docks will be assigned from the lottery.

1. The drawing will take place at 8 am on April 15<sup>th</sup> in the lodge.
2. The owner/spouse or prearranged proxy must be present at the time of the drawing to get a dock. If you are using a proxy the admin office needs to be provided that name no later than the last working day before the drawing.
3. A WPOA representative will randomly draw names and if that person is present, they will be permitted to select a dock from those available.
4. You will need to take the dock receipt to the office and pay the rental fee by close of business the day of the drawing. If not paid the dock will be offered to an alternate.
5. The drawing of names will continue until all docks are rented or no one who had signed up for the lottery is present.
6. If there are left over docks, they will be rented on a first come first serve basis until there are none available.

Note if any of the above dates fall on a Saturday, Sunday or holiday they will be extended to the next working day.
