WPOA Board of Trustees Saturday Meeting - 05/10/2025

**Any updates from the Friday email are indicated in italics of the summary of each report.

President Taylor called the meeting to order at 10:00am and led the attendees in the Lord's Prayer followed by the Pledge of Allegiance.

Roll Call: Present: Barton, Bisbee, Eads, Klein, Lane, Miller, Moore, Wagner, Mgr. Wilkin

Absent: Bynum was excused.

Minutes:

- Lane made a motion and Klein seconded to approve the 4/12/25 WPOA Monthly minutes as printed in the newsletter. A yea/nay vote was taken and the motion passed unanimously.
- Lane made a motion and Klein seconded to approve the 4/19/25 WPOA Annual Meeting minutes as distributed. A yea/nay vote was taken and the motion passed unanimously.

Membership Compliments and Concerns: Prior to opening the meeting to membership compliments and concerns, President Eads read several excerpts from the Meeting Decorum policy. As the presiding officer, she is tasked to maintain order of the meeting. Respect and courtesy should be observed at all times. This time is for members to share their opinions and concerns to the Board. It is not for the pleasure of the speaker or for the entertainment of others. Personal attacks on members will not be tolerated. People will be warned and if the bad behavior continues, removal and/or fines may be issued.

- Dave Wagner: vigorously opposed the three-minute time limit and challenged President Eads to show him where this is stated. He believes the Board does not show respect to members during their comments when they are cut off midsentence because their time is up.
- Mark Fishburn: Kids are congregating at Little Crow point. A grill and firepit have been set-up and garbage is being left behind. He is concerned about an ember catching one of the boats on fire and would like to see patrol of this area increased. He asked about people fishing off the docks and damaging boats. Mgr. Wilkin will follow-up with Mr. Fishburns concerns. Members are allowed to fish off rented docks.
- Dave Adler: Spoke with former Eagle Twp. Trustee Mr. Yockey concerning the back road conditions. Mr. Yockey suggested getting a large group of people together to attend the township meeting and possible include the lake manager and a few board members. President Eads said she has been in contact with an Eagle Twp. Trustee. Mgr. Wilkin is working with Brown County in hopes of a resolution.
- Doris Kitchen: Grasses on WPOA near Mr. Taylor's property need to be removed, survey needs done, wants playground/ swings placed there, sand moved away from dock so people can use it. Is Vern Chair of Rules & Regulations committee? President Eads responded that the natural flow of water and sand congregates in front of the dock. Maintenance will remove. Playground equipment must be approved by the Board before installation. Yes, Vern is Chair of R&R. The committee only makes suggestions. Nothing is passed until it is reviewed by the Board. Trustee Klein commented that Vern is not the right choice for Chair.
- William Blom: people on committees should be vetted. He opposes Mr. Taylor as Chair to the R&R committee. He accused Mr. Taylor of running an Airbnb. He wants a cease-and-desist order for the beach area at Mr. Taylor's property.
- Nancy Hewes: Thank you Dave and Nancee. Our 2nd Town Hall meeting will be on May 31st in the Lodge beginning at 10am. Everyone is welcome. Please plan to attend.
- Kim Kramer: There is a very dangerous situation near the campground with construction debris (gravel & mud) being left in the roadway. This is especially dangerous for bicyclists. Mgr. Wilkin responded that letters have been sent to contractors within the lake which holds them accountable for their work site cleanup. He is going around enforcing compliance. Thank you for letting him know. Please call the front office to report issues.
- Jim Hewes: Thank you to Dave for his comments. Let's do good for Lake Waynoka and change the rules, if needed. He denies any vendetta against the owner of the misappropriation of WPOA Property allegation and stated it was in the best interest of members to have this matter investigated. He disagrees with the three-minute time limit and said it is not followed for all members. Mr. Hewes voiced his displeasure of his statement not being printed in the newsletter as was given to the assistant recording secretary. He gave his statement to Secretary Moore for inclusion in the upcoming newsletter.

^{**}The deadline for submission of information for the monthly newsletter and other media releases is the Tuesday following the WPOA meeting at 4pm. The Office staff appreciates the cooperation of all of the clubs to share the events and activities held at Lake Waynoka.

- Darla Miller: Thank you Dave and Todd. The Officers of the Board are elected by a popularity contest, it is unfair and does not reflect the entire community's vote for Trustees. Some Board members are not included in meetings. It silences our voice. Many people do not understand how the Board works and it is confusing. What do you do? What do you accomplish month after month? The same issues are brought forth but not addressed. It gets old hearing that the Blue Book says this or that when sometimes it is thrown out the window. Why did the WPOA pay for attorney to represent Mr. Taylor? Vice President Barton answered that after allegations were made accusing the entire Board of a cover-up, the attorney was brought in to protect the interests of the WPOA. He defended the Executive Committee election and said it is defined by the CODE and Officers are selected by all 9 members of the Board even though the results may be unpopular. President Eads said the CODE was followed with Election Committee oversight and there is a difference of opinion in the interpretation of the CODE concerning proxy (absenteeism) voting. Trustee Klein disagrees and said the CODE was not followed last year in appointing Officers. She would like to see language updated in the CODE concerning the Executive Committee and their responsibilities. She feels they took liberties in relation to the allegations against Mr. Taylor. Trustees not on the Executive Committee were not informed of our attorney being involved until the Monday workshop before Saturday's meeting. She would also like to have more open dialogue in regard to electing Executive Committee Officers before the Annual Meeting.
- Sandy Beard: She is tired of hearing the beach area discussion at the WPOA and Mr. Taylor's properties.
- Tiana Shell: Thank you for volunteering on the Board. She is disappointed that the Board is not united. She appreciates the diversity of Trustees but dislikes the arguing in front of members. Trustee Klein believes that members should know where Trustees stand on issues since the workshops are closed to members.

President's Report (Eads):

 President Eads reported that \$4,800 was spent on the OLCA lawyer after an allegation was made concerning misuse of a WPOA owned property. President Eads did research on short-term rentals. She found no listings on VRBO and Airbnb. She does agree that the language needs to be better defined and updated in our Rules & Regulations. Our R&R state that this is a residential community. Treasurer's Report (Lane):

Operating Funds

- April total operating income was \$364,764.55.
- April total operating expenses were \$268,612.86 with no unexpected expenses.
- Operating fund balance at the end of April was \$1,291,356.17.
- Operating income for the year at the end of April was \$1,830,167.15. That is 56% of the plan for 2025. Expected income at the end of April was 58% so 2% under budget.
- Operating expense for the year at the end of April was \$957,782,35. That is 30% of the plan for 2025. Expected expense at the end of April was 30% so on budget.

Allocated Assessment Funds

- Income for allocated operating assessments in April was \$78,335.30.
- Assessment account expenditures in April totaled \$27,732.40. This includes \$21,735.00 for the striping of Waynoka Drive.
- Balance of all allocated assessment accounts at the end of April was \$1,130,473.87.

Invested Funds

Invested Reserves at the end of April totaled \$540,831.87.

Treasurer Lane stated that the annual audit has been completed and we are waiting for the official report.

Total cash on hand at the end of April was \$2,962,661.91.

Manager's Report (Mgr. Wilkin):

This month, we are introducing something new to our reporting: employee and member recognition. Each month, we will highlight one outstanding employee and one exemplary community member. A permanent plaque for the Employee of the Month will be installed in the Lodge, and a similar plaque for Member of the Month will follow. For now, both honorees will receive certificates in recognition of their contributions. We will have pictures and summaries shared on Facebook. The employee of the month award goes to Jared Foust. He joined the Rec Center team last year. He has demonstrated good initiative and a positive attitude. He volunteered to become licensed to teach CPR to our lifeguards which will save the WPOA money. The member

of the month award goes to Terry Borgman as selected by the Board. Terry provides an outstanding service to our community and volunteers countless hours serving on the LRPC and other clubs. Please send community member nominees to todd@lakewaynoka.com.

- Operational Updates:
 - Roadway Improvements: The yellow line around the lake has been repainted. While the project is complete, we've noticed some peeling and chipping and will be contacting the installer to resolve this issue. Additionally, parking stall lines at the Administration Building were moved back from the road to improve vehicle space and safety.
 - Weather Precautions: The recent rainfall has been substantial. We encourage all boat owners to monitor forecasts and consider loosening tie-downs during heavy rain events to prevent damage.
- Upcoming Events:
 - Community Yard Sale: Saturday, May 17th: This is an open gate event. Only the front gate will be open for visitors. Residents with RFID access may still use the back gate.
 - Music on the Green: May 23rd. Kicking off the summer with the Rubber Duck Regatta, followed by our first Music in the Green event.
 - Marina Pointe Concert: May 24th. Live music and festivities at Marina Pointe from 5p-10pm.
- Marina Pointe is now being managed by our Events Coordinator, Mrs. Chy King. The previous lease operator no longer manages this area. Mrs. King and our staff will oversee maintenance, including trash removal and lawn care. If you are interested in sponsoring events at the Pointe, please contact Mrs. King.
- Grounds and Clean-Up:
 - Mowing and Beautification: We are actively mowing vacant lots and addressing tall grass concerns, weather permitting.
 - Blight Remediation: We will be removing the boat and trailer from the front entrance by Memorial Day and will be enforcing the removal of derelict boats and vehicles around the lake. Lot owners are responsible for these items, and enforcement will be stepped up.
 - Marina Clean-Up: We have removed 20-25 boats, an RV, multiple wooden structures and over 150 tires from the boat maintenance area. These items had accumulated over several years. The cost of this cleanup will be covered by the former Marina Lease Operator.
- We are looking forward to an exciting and safe boating season at Lake Waynoka. Thank you to everyone for your continued cooperation and commitment to our community.

- We will have a booth at Waynoka Day to answer questions and encourage members to sign up for email blasts.

WRWSD Board of Trustees Saturday Meeting - 05/10/2025

President Levermore called the meeting to order at 9:30am.

Roll Call: Present: Armstrong, Feil, Harper, Levermore, Moore, Wales, Mgr. Wilkin

Absent: Kost was excused.

Minutes: A motion was made by Harper and seconded by Armstrong to approve the 4/28/25 minutes as distributed and read. A yea/nay vote was taken and the motion passed unanimously.

President's Report (Levermore): None

Treasurer's Report (Feil): The financials at the end of December 31,2025 have been audited and no issues were found. Treasurer Feil signed off on the report.

Manager and Plant Superintendent Report (Mgr. Wilkin/Supt. Wilson):

- In 2022, it was found that WRWSD EPA violations were being sent to the operator's home email. Brown County brought it to the attention of Vice President Moore who then informed President Levermore and Mgr. Cahall. The operator was terminated and a third-party company was brought in to manage the WRWSD operations in the interim and all violations were corrected. Currently, we are in EPA compliance and have implemented several safeguards to prevent this from occurring again. EPA violations are sent to Brown County, the WRWSD Superintendent (Wilson), WRWSD President of Record (Levermore) and the Lake Manager (Wilkin).
- We are working on bulk chemical storage designs as required by the EPA.
- The actual capacity of our water and sewer systems is being researched by Supt. Wilson and DLZ Engineering.
- Supt. Wilson and Licensed Operator Pike attended a required continuing educational annual license seminar. They learned a promising new manganese treatment is available.
- The dam valve is scheduled to be replaced in June.
- Mgr. Wilkin expressed his appreciation for the WRWSD staff. Their work is essential to maintain our water and sewer systems that we often take for granted. They mostly work behind the scenes but their work is critical and professional. If you happen to see them out in the community, please take a moment to thank them for their hard work.

Old Business: None New Business: None

Motions and Resolutions: A motion was made by Wales and seconded by Armstrong to approve the April 30th financial statement as distributed. A yea/nay vote was taken and the motion passed unanimously.

Give your grinder pump air!

If you are going to landscape around your grinder pump, the grade around the pump should be a minimum of 4" below the top of the lid and sloped away from the unit.



WRWSD Board of Trustees Monday Meeting - 04/28/2025

President P. Levermore called the meeting to order at 6:00pm.

Roll Call: Present: Armstrong, Feil, Harper, Levermore, Moore, Wales, Mgr. Wilkin, Supt. Wilson Absent: Kost was excused.

Minutes:

- A motion was made by Wales and seconded by Harper to approve the 4/12/25 Monthly Meeting minutes as distributed. A
 yea/nay vote was taken and the motion passed unanimously.
- A motion was made by Wales and seconded by Harper to approve the 4/19/25 Annual Meeting minutes as distributed. A yea/nay vote was taken and the motion passed unanimously.

President's Report (Levermore):

- There may be a WRWSD Trustee vacancy in the near future. The search committee will begin looking for people interested
 in serving. President Levermore will make public announcements according to the WRWSD bylaws and people interested
 can submit an application at that time.
- There are many bogus emails going around asking for money that appear to be from Board members. Mgr. Wilkin asked everyone to use caution and if it is an email asking for money, it is usually fake/bogus. Please reach out if you are unsure.
- The budget at the last monthly meeting was printed using our new Quickbook software. Unfortunately, the only printing
 options are black and red. This was confusing to members. Mgr. Wilkin will be sure to make copies from our printer so the
 handouts will be in black.
- President Levermore passed out a draft for the Board to discuss concerning WRWSD future objectives and goals. The Board decided to table the discussion until we receive more information from DLZ.

Treasurer's Report (Feil): Treasurer Feil and Supt. Wilson discussed increases in appropriations. The water and wastewater operator transfer switches have issues. The electronic sensors are obsolete and not working properly. They are designed to transfer power to the generator during power outages. Grinder pump purchases are exceeding what was budgeted for 2025. We will need to adjust the budget for the \$854 current deficit of the budgeted \$125,000.00. The Board was told that we will need to make several more grinder pump amendments throughout the year to keep pace with the number of new home tap requests. We have enough funds from our operating budget to cover repairs and replacements for existing grinder pumps.

Manager and Plant Superintendent Report (Mgr. Wilkin/Supt. Wilson):

- Safety training and educational seminars are of the utmost importance for our WRWSD staff. Safety Data Sheets have been updated and are posted appropriately. Supt. Wilson holds two hazard meetings per week to educate the crew. He would like to host a safety seminar for surrounding communities at Lake Waynoka in the Lodge. All the Trustees thanked Supt. Wilson for prioritizing safety and education for our staff.
- Supt. Wilson is exploring alternative ways to remove algae and manganese from the water.
- We have a new hire starting Monday.
- The digester sludge tanks have been pumped out for the year.
- The low service pump is being rebuilt.
- We have 16 tap requests and are working to get them installed.
- GIS infrastructure maps are being updated by Supt. Wilson and DLZ.
- The dam valve replacement is scheduled for June.
- Water usage has increased 200,000 gallons per month.
- We have a 30% water loss and are trying to track leaks. We may have to contract a company to test the lines to help trace the leaks.
- Supt. Wilson is using the new software to compare the flow of water to the sewer plant during rainfall vs. normal
 wastewater return. The spikes occurring during rain validate the theory that several sump pumps and/or gutters are
 draining into the sewer system. He and DLZ are continuing to look at the data and will provide an updated report to the
 Board.
- Grinder pump service calls are down. The newly implemented QR code system is working very well.

- Vice President Moore would like to have a WRWSD plant tour again this year for the community. Everyone agreed. We will look at possible dates and times.
- Trustee Harper asked if the crew can tell if people are abusing their grinders. Supt. Wilson said yes. The biggest issue they find is the flushing of baby wipes.

Motions and Resolutions: Motion #2025-16 was made by Moore and seconded by Harper to amend the 2025 expense budget as follows: 854-03 equipment, maintenance, vehicles budgeted amount \$3,000.00, amended amount \$7,447.05; 2854-03 equipment, maintenance budgeted amount \$3,000.00, amended amount \$7,447.06; 9820-01 Purchase grinder pumps budgeted amount \$125,000.00, amended amount \$125,854.00. A roll call vote was taken and the motion passed unanimously. Board Member Concerns: None

Executive Session:

- At 6:40pm, a motion was made by Wales and seconded by Armstrong to enter into executive session to discuss a pending legal matter. A roll call vote was taken and the motion passed unanimously.
- At 7:14pm, a motion was made by Armstrong and seconded by Harper to exit executive session. A roll call vote was taken and the motion passed unanimously.

Adjournment: The motion to adjourn was made by Harper and seconded by Moore. A yea/nay vote was taken. All were in favor and the meeting was adjourned at 7:15pm.

- > Use of silt fence with any excavation. This will reduce erosion into the lake and help with dredging
- > Shoreline protection-all rock is not the same. 6"rip rap should be the minumum as it won't get washed away
- > Secure trash containers on dock and near lake
- No blowing or raking of leaves or grass in lake
- ➤ Eco friendly boat fluids and boat wash (biodegradable, non-toxic)
- Dewinterize your boat on land not in water
- Avoid overspray when staining/painting docks
- Rock ditches and drain pipes
- > Avoid moving any rock on dam
- Clean up area at public docks and remove all trash when you leave the area
- > Recycle motor oils
- > Be mindful of lawn fertilizers and weed killers as all runoff goes in the lake






